**Changes to Classes** - Some classes may be capped and closed before official Close of Entries if entries too great. Classes with less than 5 entries by Closing Date may be cancelled.

**Late entries** – Entries after Wednesday 6th January 2021 incur \$20 late fee.

**Scratchings** – Refunds less 20% of Class Entry Fee if notified by 9am Thursday 14th January 2021. Admin & Medical Fee is not refundable. Thereafter no refunds for any reason. No refunds on late entries.

**Yards & Camping** – Yards \$25 per horse, limited stallion yards \$45 per horse, camping \$25 per vehicle/float. To be paid with entries.

1. To start all riders in classes 1 to 8 must have current ESNZ membership. Riders can start classes 9 and 10 on a casual ESNZ membership of \$15.
2. Unregistered horses in classes 5 to 10 may start on a casual ESNZ Equine Registration of \$5 per horse.
3. Unregistered horses, or horses with no eventing discipline start, may start in classes 5 to 10 with an Eventing Flexi Start of \$15 per horse.
4. Rider Age classes are from the first day of the season in which the athlete reaches 22 years for class 4 and reaches 19 years for classes 6, 8 and 10.
5. No unauthorised motorbikes on the grounds.
6. Food and farrier available on grounds.
7. No person under the age of 18 may consume alcohol on the Clevedon A&P Showgrounds.
8. Dogs must always be on a lead. If this rule is not adhered to, competitor may be fined/eliminated at the discretion of the Clevedon Horse Trial Committee.
9. The Clevedon Horse Trial Committee reserves the right to alter the programme, classes and prize money, and to substitute prize money with goods to the value of, at their discretion – Article 611.
10. No Non-competitive horses on the grounds at any time.
11. As a condition of entry all local riders must supply a helper prior to or during the event.
12. All classes part of ESNZ Eventing National Series Competitions.
13. All classes run under ESNZ Eventing Rule.
14. There are 70 yards onsite that will be allocated on a first come basis. Additional yards and overnight camping are available at Springbush, Hunua.

#### **COVID-19:**

If at any time prior to the start of the event the current COVID-19 Level 1 status changes the Clevedon Horse Trial Committee reserves to cancel the event. Riders will receive full refund of their Class Entry Fees if the event is cancelled before close of entries and 80% of their Class Entry Fees if cancelled after the close of entries.
