+ Yards/Stables: Per horse – Loose boxes \$45 for event or Yards \$35 for event at Waipukurau Racecourse or Yards at Waipukurau Show Grounds - \$25 for event (approx. 15 minutes to venue) - Camping is free – No camping or yarding for horses available at venue. Limited yarding available at Orua Wharo Station on first in/first served basis

+ FEI Rules of Eventing to apply to Classes 1 – 3 and ESNZ Rules of Eventing to apply to Classes 4 – 11

+ All horses in class 1 are required to have FEI Passports and in classes 2 & 3 are required to have either FEI Passports or fully completed Official ESNZ Identification Papers

- + Refer to Minimum Eligibility Requirements (MER) for details of qualification criteria. Any entries that have not met the required MER will not be accepted until MER have been met as per MER deadlines
- +All riders MUST be Full Members to compete in classes 1 – 7 and Introductory Members to compete in classes 8 - 11. For classes 10 & 11 a casual day membership of \$10 can be paid
- +Full ESNZ Equine Registration and Eventing Annual Start required for classes 1-5.
- +Casual ESNZ Equine registration (\$5) permitted for classes 6-11 plus Discipline Flexi-start of \$15 for unregistered horses in classes 6 & 7 only.

CONDITIONS:

- a) **NO DOGS ALLOWED** (automatic rider disqualification if not complied with)
- b) **Payments for entries received more than 2 days after 18 October 2017 will incur a non-refundable \$50 late fee**
- c) **All scratchings must be emailed**
- d) Entries from Hawke's Bay Riders are required to supply name of one volunteer, in the special requests area of the online entry, however the Committee welcomes any offers of help on the day
- e) Looseboxes and yards at Racecourse will be allocated and advised by email. Competitors yarding horses at the show grounds should be aware that not all yards have chains and to make provision for this. All looseboxes and yards must be left clean or a fine will be applied.
- f) Hot food and drinks will be available on the grounds.
- g) No vehicles allowed on cross country course except officials
- h) Liability: ESNZ Article 610: Neither the Organiser of any event to which these rules apply nor the NF nor any agent, employee or representative of these bodies accepts any liability for any accident, loss, damage, injury or illness to horses, owners, riders, spectators, land, vehicles, their contents and accessories or any other personal property whatsoever whether caused by their negligence, breach of contract, or in any other way whatsoever.
