DETAILS OF OWNERSHIP

1. The nationality of the horse is that of its owner.
2. On change of ownership the passport must immediately be returned to the NF for re-registration. The name and address of the new owner are clearly indicated. The passport is registered and then forwarded to the new owner.
3. If there is more than one owner or the horse is owned by a company, the name of the person responsible for the horse shall be entered in the passport with her/his nationality. If the owners are of different nationalities, they have to determine the nationality of the horse.

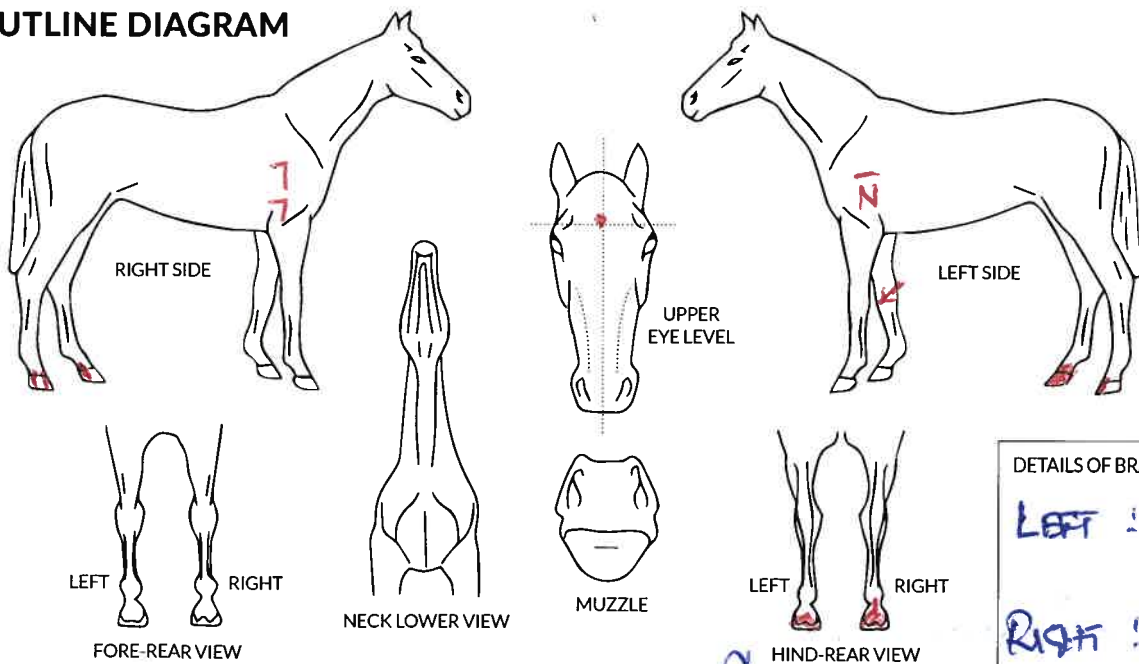
